Note: **The aforementioned rates and fees are subject to annual cost of living adjustments as indicated by the change in consumer price index for the previous 12-month period for which such data is available, plus any additional costs incurred by the District. The consumer price index to be used shall be the U.S. Cities Average as indicated on the annual April consumer price index for Pacific Cities and the U.S. Cities average.**

**A community water system shall deem a residential customer to have a household income below 200 % of the federal poverty line if any member of the house hold is a current recipient of calWORKS, CalFreash, general assistance, Medi-Cal, Supplemental Security Income/State Supplementary Payment Program, Or the California Special Supplemental Nutrition Program for Women, Infants, and Children, or the customer declares that the household's annual income is less than 200 % of the federal poverty level.*
